




proceeding. The reasonable value of the services, as set forth in the itemized list attached to the motion, is \$4,181.50. (Document No. 39, Ex. A). Grier Furr & Crisp, PA, has also incurred expenses in the amount of \$208.28.

The Receiver served a “Notice of Third Motion For Compensation To Grier, Furr & Crisp, PA., Attorneys For Temporary Receiver” (“Notice”) upon the parties as required by law. (Document No. 39-1). The Notice required that responses to the motion be filed with the Court on or before **May 3, 2010**. No responses to the pending motion have been filed.

**IT IS, THEREFORE, ORDERED** that “Third Motion For Compensation To Grier Furr & Crisp, P.A., Attorneys For Temporary Receiver” (Document No. 39) is **GRANTED**.
